THE EXCISE ORDINANCE

Excise Notification No. 661

THE Minister of Finance and Planning has under Section 25 of the Excise Ordinance (Chapter 52), directed that with effect from January 01, 1980--

- (1) Every licence for the sale of arrack-
 - (a) by the bottle only (not to be consumed on the premises) in Foreign Liquor Retail (off) licensed premises;
 - (b) in premises licensed for the sele of Foreign Liquor other than by retail (off) Licence;
 - (c) in Foreign Liquor Taverns licenced for the sale of Foreign Liquor (including locally made Malt Liquor) to be consumed on the premises;
 - (d) in Resthouses licenced for the sale of Foreign Liquor (including locally made Malt Liquor); and
 - (e) in premises specially licensed for the sale of Foreign Liquor (including locally made Malt Liquor);

shall be issued-

- (i) on the payment of the appropriate fee calculated at the rates set out in Schedule I heroto;
- (ii) for a period of not more than one year;
- (iii) in the appropriate form set out in Schedule II hereto; and
- (iv) subject to the restrictions and on the conditions contained in the said forms; and
- (2) That Excise Notification No. 649 published in Gazette of the Democratic Socialist Republic of Sri Lanka No. 14 of December 1978, shall be rescinded.
