ADMINISTRATIVE REPORT OF THE COMMISSIONER GENERAL OF EXCISE FOR THE YEAR 2007

Introduction

The Department of Excise comes under the purview of the Ministry of Finance and Planning. It has the legal authority for the implementation of the excise policies of Government and relevant activities including the protection and collection of excise revenue, principally under the Excise Ordinance (Chapter 52 of the Legislative Enactment). In addition, the authority and responsibility for administration of the Tobacco Tax Act No. 08 of 1999, the collective responsibility for the enforcement of Poisons, Opium and Dangerous Drugs Ordinance with the Police and other relevant Agencies and the responsibility of effecting of National Authority Act No.27 of 2006 on Tobacco & Alcohol are also mandatory functions delegated to the Department. The Department also acts as a principal agency holding the authority for the enforcement of provisions of the above Ordinances, Acts and consequential rules and regulations, notifications, orders and directives. The Department is engaged in performing a national mission providing social security by collecting considerable amount of revenue to finance the country's economic development as well as by preventing and detecting illegal activities of every description falling under the above legislations.

2. VISION:

Building of healthy society in Sri Lanka, which is free from illicit liquor and narcotic drugs.

3. MISSION:

Efficient and effective administration of the liquor and the tobacco industry in Sri Lanka through the collection of revenue and prevention of illicit manufacture and sale of such products, for development and welfare of the society, and the enforcement of the Poisons, Opium and Dangerous Drugs Ordinance for the social protection of Sri Lanka.

Objectives:

- a. The collection and protection of revenue from liquor and tobacco.
- b. The enforcement of the Excise Ordinance and the Tobacco Tax Act.
- c. The effecting of the Poisons, Opium and Dangerous Drugs Ordinance.
- d. The effecting of National Authority Act on Tobacco and Alcohol.

Functions:

- a. Supervision and control of licensed premises, and collection of revenue there from.
- b. Acting as the law enforcement agency in respect of the Excise Ordinance.
- c. Enforcement of the Tobacco Tax Act including supervision and control of tobacco manufactories.
- d. Acting as a law enforcement agency in respect of the Poisons, Opium and Dangerous Drugs Ordinance.
- e. The effecting of National Authority Act on tobacco and alcohol.

A Superintendent of Govt Audit also participated in these meetings as an Observer. Action was taken to solve the problems faced in managing the resources including human resources

35. FUNCTIONS OF SPECIAL OPERATION BUREAU (S.O.B)

a. Colombo Unit

This Unit has been under the supervision of the Commissioner General of Excise. The Unit is administered by the Commissioner of Excise (Crimes/Training). 01 Superintendent of Excise, 03 Excise Inspectors including an Excise Officer In-charge and a staff of 16 other officers have been working in this Unit.

This Unit bears the responsibility of curbing all excise crimes in all areas, inquiring the complaints received to the Commissioner General of Excise from Public. Details of detections carried out by this Unit during the year 2007 are appended below:-

During the year 2007 a sum of Rs 22,457,750/= was recovered from the raids conducted by this Unit. A sum of Rs 8,479,764/25 was recovered from offences committed in licensed premises.

The Officers of this Unit managed to detect 11 Ganja Chenas, and 147,000 Nos of Cigarettes by 04 Cigarette raids.

b. Central Province Unit

This Unit has been under the supervision of the Commissioner General of Excise. The Unit is administered by the Commissioner of Excise (Crimes/Training), Assistant Excise Commissioner (Central Province) and the Superintendent of Excise (Special Operations). An Officer In-charge including an Excise Inspector, an Excise Sergeant, 06 Excise Guards, 01 Female Excise Guard, an Excise Driver are working in this Unit. This Unit which established in the year 2003 was actively operated in Central, Uva, North, North Central and Eastern provinces. On the orders and instructions of the Commissioner General of Excise, the duties of this Unit were expanded island-wide.

Through 1253 raids conducted, 1253 personnel were taken into custody during the year 2007, and a sum of Rs 10,479,150/= was recovered from the raids. 256 of unlawful distilled Centres were detected. 17,790 of Ganja plants were destroyed by detecting of 05 acres of Ganja Chenas. 103,820 of Non Tax Paid Cigarettes were taken into custody by 04 Cigarette raids and Rs 808,500/= recovered as fines.

With regard to violation of excise rules, 361 Technical Crime Reports were submitted. A sum of Rs 10,045,000/= was recovered by compounding offences committed in licensed places.

a. Southern Province Unit

Under the supervision of the Commissioner General of Excise, this Unit has been administered by the Commissioner of Excise (Crimes/Training) and Assistant Excise Commissioner (Southern Province). An Officer In-charge including 02 Excise Inspectors, and 04 Excise Guards are working in this Unit. In the year 2007, 600 detections and 62 Technical Crime Reports were carried out by this Unit.

Unlawful liquor distillering places at Benthara, Walambagala, Elpitiya and Hiyare Reservoir were destroyed by this Unit.

36. ACTIVITIES OF THE MANUFACTURING OPERATION UNIT:

Under the control of the Commissioner General of Excise, this Unit has been administered by Excise Commissioner (Crimes/Training) with the guidance of Assistant Excise Commissioner. The Staff consisting of Chief Excise Inspector, 03 Excise Inspectors, a Female Excise Corporal, a Female Excise Guard and an Excise Driver. In addition, an Excise Inspector is attached to Greyline Custom Yard at Orugodawatta to monitor the matters relating to importation of spirits.

The main functions of this Unit are the supervision of Distilleries, Liquor Manufactories, Toddy & Wine Manufactories, Liquor Wholesale licensed places established island wide and collect excise revenue. The Officers attached to this Unit, inspect these places regularly and submit Technical Crime Reports if they found any offences occurring in these places. They also provide advises to these Establishments regarding the excise rules and regulations and keep them under close supervision.

This Unit maintains statistics in relating to Liquor Manufactories and carries out activities relating to payment of rewards with regard to Technical Crime Reports.

Through supervising the licensed premises, 108 Technical Crimes Reports were submitted during the year 2007 and Rs 4,794,962/50 has been collected as composition fees. In 2007, a rigorous irregularity in manufacturing of Arrack in a Liquor Manufactory was detected by this Unit, and it was handed over to the Attorney General's Department for relevant legal measures and further action will be taken on legal advices. Another incident was discovered from a Liquor Manufactory on unlimited wastage of spirits, and a Committee comprising of 03 Assistant Excise Commissioners were appointed to inquire into this. This Unit closely monitored the licensed manufacturing establishments in order to achieve the targeted revenue.

37. ACTIVITIES OF THE NARCOTICS UNIT:

The Narcotic Unit has established for the enforcement of law under the Poisons, Opium and Dangerous Drugs ordinance is in operation at D.R Wijewardena Mawatha, Colombo 10. This Unit operates under the supervision of a Superintendent of Excise with 26 other Officers, including an Officer In-charge.

693 detections were made during the year 2007 and 573 males and 89 females were taken into custody. Out of the 693 detections, 261 were connected to Heroin, 401 were connected to Ganja detections. 40 cases were filed in High Courts and Rs 1,618,250/= was recovered as fines.

38. ALCOHOL CONSUMPTION

When comparing the alcohol consumption figures with the year 2006, it can be observed a slight reduction of Beer consumption while an increase of arrack consumption. The increase of arrack consumption is mainly shown in the districts of Colombo, Gampaha and Kurunegala. More than 20,000 excise detections had been carried out during the year 2007 in these districts. The statistics are as follows:-

These detections include large scale illicit liquor detections carried out in these districts by the Excise Special Operation Units. Due to these reasons, an increase of legal liquor consumption was shown in these districts.

It has also been evidenced by the external observers that there was a decrease in illegal alcohol production. The contribution made by the Police Department in the control illegal liquor is commendable. Although an increase of liquor consumption is shown in statistics, this trend would be changed in the future, due to the policy of present government on liquor.

39. EXCISE CRIMES:

The number of raids conducted in order to curb the unlawful menace of illicit liquor was increased in the year under review. Though the target for the year was 58000 detections, it was able to detect 56476 raids. Rs 269,220,017/= were recovered as Court fines.

Comparing to the year 2006, percentage increase of detection is 3.48%

40. ASSAULTS & OBSTRUCTIONS:

- A Complaint was made to Thanamalvila Police Station regarding a robbery of Rs 228,000/= from the Excise Officer who was acting as the bogus customer, when detecting a Ganja raid by the Excise Officers attached to Hambantota. This Suspect is in open warrant.
- ➤ A Case has been filed at Balapitiya Magistrate Court against the accusers in relating to obstructions made, to the Officers of Southern Province Special Operation Unit, when they were detecting a raid at Akuruwella, Induruwa on 31.07.2007.

41. FISCAL MANAGEMENT REFORM PROGRAMME (FMRP)

The main objective of this Programme is to modernize the revenue administration of the Department, strengthening the system of financial management, and to assist the Government to control financial deficits. All Officers of the Department were given one week Computer training under this project.

CONCLUSION

The excise revenue collected during the year under review is Rs 24052 million, and that is an increase of 16.2% compared to year 2006. The Department conducted 56476 raids in 2007. Accordingly, I am pleased that we have been successful in fulfilling our responsibilities during the year under review. The increase in arrack consumption when compared with the last year was observed. This is mainly due to the successful control of illicit liquor.

The success of the department was due to the qualitative improvements made in the operational activities through proper using of limited resources and systematic human resources management.

I am thankful to His Excellency the President, the Hon Minister of State Revenue & Finance and Deputy Minister of Finance & Planning, and the Secretary to the Ministry of Finance for giving me the strength, directions and guidelines to carry out my duties in accordance with the Excise Ordinance and the connected legislations, through continuous review of our activities, and to the Deputy Secretaries to the Treasury who cleared the hindrances by co-ordinating and constantly giving instructions. I also wish to thank all other officers and the staff of the Ministry of Finance who assisted us in this task.

Also, I am grateful for the assistance extended to me by the District Secretaries and the Divisional Secretaries to perform our functions of the Department properly. I also wish to thank and extend my gratitude to the National Dangerous Drugs Control Board, Attorney General's Department, Police Department and the Government Analyst Department for the friendly assistance offered to the Department to achieve its goals.

The support extended to this Department by the Fiscal Management Reform Programme (FMRP) which is funded by the Asian Development Bank, is appreciated. I specially thank to the Project Directress of the FMRP and Consultants of Prizewater House Coopers Private Limited for their assistance and guidance given to us to make progress in the process of modernizing the Department.

Finally, I extend my special thanks and gratitude to my dedicated and courageous staff from every grades who contributed to the success of the Department.
