## Forms and Conditions of Foreign Liquor Licences

THE Governor has, under section 24 of "The Excise Ordinance, No. 8 of 1912 directed that on and after October 1, 1931, licences for the manufacture of liquor and for carrying out any business in foreign liquor shall be granted—

(a) on payment of the fees shown in Schedule I;
(b) for a period of not more than one year;
(c) in the forms given in Schedule II;
(d) and subject to the restrictions and on the conditions contained in said forms.
